- I. Susan called meeting to order at 12:53
- II. New board members were welcomed

 - b. Tina will send everyone notes from the pre-conference meeting as well as the business meetings
- III. Financial report was given by Chad letting us know that the current checking account has \$22,297.98 and our CD has \$45,505.36
- IV. Matt had nothing new to share for the President's report
- V. Matt said we had a preliminary number of 97 registrants for conference
 - a. He hoped to make about \$2500 from this conference but will have definite numbers at the summer board meeting
- VI. Unfinished Business

 - c. The legislative chair, Kevin Lawrence, will also be given a budgeted amount of money to pay for his flight and room which is under the legislative budget line
- VII. New Business
 - a. Matt will come up with a plan for advertising and a vote will be made at the summer board meeting

- b. Chad will look into purchasing a timer for the student papers to be used for future conferences
- c. Clickers were discussed and software is being looked into for them to be used on a Mac
 - i. Sites will continue to hold the quiz bowl
 - ii. Matt will update in the conference manual to check with treasurer on budget for how to set up the quiz bowl
- d. Susan will put together an agenda for the banquet to be put in the conference manual as well as President's jump drive
- e. Bylaws were sent to be reviewed with proposed change for the Life Membership to go from 10 years of membership to 30
- f. The conference manual will be updated to include 4 free giveaways from the SDSRT and to have Susan Choal provide 4 membership cards to be given out. These include:

- g. Graduations are to be attended by an SDSRT member
